THE WILL OF PETER PIPPERZ**

**TO:** The Trustees for the time being and from time to time of **THE WILL OF PETER PIPPERZ OF Auckland, Baker.**

**FROM:** **PETER PIPPERZ**

**1. PERSONAL DECLARATION**

- 1.1 My will can be found at 20 Spring Street, Onehunga, Auckland, 1061, New Zealand, On top of the fridge.
- 1.2 Where organ donation and disposal of my body instructions differ in my will the wishes in this document should take precedence.
- 1.3 Notwithstanding 1.2 this document is not intended as a will. Should anything I say in this document conflict with, or seem to conflict with, any provision of my will, the will shall be followed.
- 1.4 This document expresses feelings, provides reasons and sets out my wishes which I request you to take into account in the administration and management of my will.
- 1.5 I understand that this document is not binding on you, the Trustee of my will, but I request that you have serious regard for the contents of it and follow it where you reasonably can.
- 1.6 I request that you share this statement with people named in my will to take property, or act as a guardian or custodian and with anyone else you determine should receive this information.
- 1.7 I am aware that my wishes may be contrary to the Family Protection Act 1955 and therefore parts of my will may be open to challenge by an "eligible claimant". Notwithstanding that it is my will to divide my property in this way and request that the courts uphold and respect my decisions where that is the case.

**2. ORGAN DONATION**

- 2.1 I request that only suitable parts of my body listed here be used for transplant purposes and direct my Trustee and family to comply with this request:
- (a) Heart;
  - (b) Kidneys;
  - (c) Lungs; and
  - (d) Heart valves.
- 2.2 I request that my de facto partner, MARY JOAN PIPER (Mary) not be permitted to harvest my sperm for use in reproduction and direct my Trustee and family to comply with this request.
3. **OMISSION FROM MY WILL**
- 3.1 I declare that I have excluded my son, PAUL PIPER (Paul) as a beneficiary of my residuary estate because of estrangement. I have left Paul out of my will as we are estranged and had no contact for over twenty years. He has shown no interest in my welfare and refused to respond to repeated attempts I have made to contact him.
4. **UNEQUAL DISTRIBUTION IN MY WILL**
- 4.1 I declare that I have made the special provision for my daughter, JANE DOE (Jane) because she has provided special care and support to me and has shown continuous consideration for my personal welfare. My other children, for a number of reasons, have not provided the same care and support.
5. **GIFTS EXPLAINED**
- 5.1 I have left in my will my art collection to Jane. I have left my entire art collection to Jane as she appreciates and love it as i do. I ask that Jane retain ownership of it and pass it on or provide it on loan to a gallery of her choosing to ensure it provides on-going enjoyment.
6. **MINOR GIFTS**
- 6.1 I direct that my property and possessions, not otherwise gifted in my will be distributed in accordance with the Schedules attached to this Statement.

6.2 I direct that all my furniture, furnishings, electronic equipment, digital assets, art, jewellery and other household or personal possessions not otherwise gifted, is to be divided among any of my children living at my death in such manner as they agree. Failing agreement I direct that my Trustee distributes in such manner as they in their absolute discretion decide.

7. **PETS**

7.1 I direct that my pets, not otherwise gifted in my will, be distributed in accordance with the Schedules attached to this Statement.

7.2 I direct that all my pets not otherwise gifted be provisioned to my Trustee to determine the identity of any pets and arrange for pets to be re-homed in suitable dwellings and/or to use funds from my estate as reasonably required to license, care for and pay veterinary bills of pets for treatment or euthanasia.

8. **GUARDIANS EXPLAINED**

8.1 I declare that I have left in my will testamentary guardianship of my son, JAMES PIPER (James) to Jane. I have appointed Jane as guardian of James as you are the closest of our family to him and will represent my values when making choices on our and his behalf. Please ensure he remains living in Auckland so the other family members can visit and know him.

9. **PERSONAL MESSAGES**

9.1 I direct that my personal messages be distributed in accordance with the schedules attached to this Statement.

9.2 I direct that any personal messages not able to be distributed be provisioned to my Trustee and I direct that my Trustee distribute or destroy in such manner as they in their absolute discretion decide.
